### **Black Hills 100 REGISTRATION AGREEMENT AND LIABILITY WAIVER (the "Agreement and Waiver")**

1. Authority to Register and/or to Act as Agent. You represent and warrant to Dakota Endurance, LLC. that you have full legal authority to complete this event registration on behalf of yourself and/or any party you are registering (the "Registered Parties"), including full authority to make use of the credit or debit card to which registration fees will be charged.

2. Waiver.
